Description:

Loneliness is a significant contributing factor to student attrition and poor mental health that has been drastically exacerbated in light of the pandemic. This presentation will highlight the 18+ month research process, development, launch, and impact of a scalable, digital intervention proactively addressing the issue of loneliness on campus. Results of a randomized controlled trial and subsequent launch at 30+ institutions, including Colorado State University and CU Denver, will be presented alongside key insights and learnings to assist campuses in decreasing loneliness amidst ongoing social anxiety and uncertainties.

Learning Objectives:

- Analyze the current state of loneliness on campuses across the nation and its associated mental health impacts, both prior to and in light of COVID-19.
- Analyze the opportunity to proactively support student belongingness and social connections to promote student mental health, well-being and success.

- Develop awareness and understanding of approaches being applied to buffer student loneliness and means to garner cross departmental support to reduce it.

CPA: Ethics Committee Vacancy - Nominate by May 15

Do you have a passion for Ethics and are looking for a way to get more involved in CPA? Do you have experience teaching and/or consulting about ethics and psychology practice? Do you have 5+ years of post-licensure experience? The CPA Ethics Committee has an exciting opportunity for you!

The CPA Ethics Committee is composed of nine CPA member volunteers, all of whom have been licensed and practicing psychology for at least five years. The committee also includes a highly valued attorney consultant. The primary purpose of the Ethics Committee is to promote psychologists' ethical conduct by providing consultation and education regarding the APA Ethical Principles of Psychologists and Code of Conduct (2016) as well as providing external referrals for legal consultation as indicated. Consultation occurs primarily via responding to inquiries phoned in to the on-call committee member through the CPA ethics consultation service. The committee also writes articles on ethics for CPA publications and facilitates educational programs. Ethics Committee members serve four-year terms and members can self-nominate to continue for an additional term. The Committee meets monthly for about 90-min. Committee members often confer with one another throughout the month around responding to consultation inquiries as well as moving forward education projects. The total time commitment for members averages approximately five hours per month. The Ethics Committee is not affiliated with the Colorado State Board of Psychologist Examiners.

Recorded on Friday, January 7: **Part 1 - Pharmacological and Psychotherapy of Depression: Update and Best Practices**

Prescribing Psychologists integrate pharmacology with psychotherapy. The American Psychological Association has released a Clinical Practice Guideline for 2022 for this topic, across three age cohorts, which primarily focuses on psychotherapy but includes pharmacotherapy. Dr. Lia Billington's presentation of this topic will primarily focus on pharmacology to equip the consulting or future prescribing psychologist on the rationales for using certain antidepressants over others, and including initial dosing and titration, along with possible adverse effects. Case examples will illustrate features of treatment plans utilizing specific pharmacotherapies and psychotherapies. Foundational concepts from this webinar will be referenced in a second webinar on treatment of anxiety.

Recorded on Friday, January 14: **Part 2 - Pharmacological and Psychotherapy of Anxiety: When does CBT (or other modalities) need add-on pharmacotherapy?**

In this second part of a two-part series about the integration of pharmacotherapy with psychotherapy, the rationales for adding medications to psychotherapy for anxiety will be explored. Additionally, two special populations will be explored: (1) clients with co-occurring anxiety and depression, and (2) patients with co-occurring substance use disorder, in particular clients in partial or sustained recovery. Case examples will illustrate features of treatment plans utilizing specific pharmacotherapies.

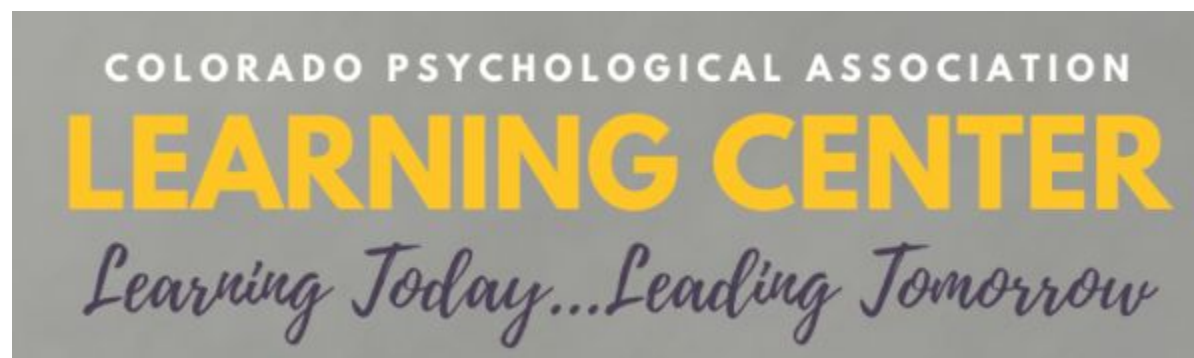
